


KENYA


- Sir Mo Farah, Olympic gold medalist and six-time long-distance world championship runner was in Kenya for his inaugural visit as the first IOM Global Goodwill Ambassador. During his visit, he met with over 200 migrants, government stakeholders, development partners, and UN family, to raise awareness and increase support for the needs and aspirations of migrants in Kenya and advocating for sport as a tool to build confidence and integration. <u>Read more</u>
- ▶ IOM supported organizing the first-ever National Border Management Conference in Kenya on the theme "Building on Coordination and Moving towards Integration." 

#### ABOUR MOBILITY AND MIGRANT PROTECTION



The Labour Mobility and Migrant Protection programming supports the effective management of the social, economic, political, developmental, environmental, and humanitarian factors underpinning migration, empowering individuals, families, and nations to attain their development aspirations. Guided by the principle of safe, orderly, and regular migration and working at all stages of the migration process in close collaboration with the Government of Kenya, migrants, diasporas, aid partners, and other stakeholders, IOM focuses on establishing, expanding, and enhancing regular labour pathways, supporting skills-based and talent mobility schemes, facilitating human and economic mobility, protecting and assisting migrants and their communities, upholding their rights and dignities, facilitating the identification of migrants in vulnerable situations, and ensuring that they receive appropriate, immediate, and longer-term support, assisting migrants in making informed decisions in their migration journeys, optimizing the developmental potential of migration, improving the legislation, systems, and structures required to respond more effectively, and regulating migration that works for all.





### **IMMIGRATION AND BORDER MANAGEMENT**



The Immigration and Border Governance programming supports the Government of Kenya to establish a comprehensive and integrated border management system to facilitate safe, orderly, and regular cross-border mobility and trade and to effectively address transnational organized crimes, including trafficking in persons as well as smuggling of migrants and goods to, from, and within Kenya. This includes programmes and policy initiatives that enhance mobility and regular pathways for migration, provision of technical support, capacity strengthening, improvement of border infrastructures, and enhancing inter-agency and cross-border cooperation. In addition, IOM supports community engagement initiatives to increase trust and promote a collaborative relationship between border communities and law enforcement authorities for enhanced border security.

In addition, IOM runs a Family Assistance Programme (FAP) Centre in Kenya, facilitating the family reunification of vulnerable migrants with their family members in Germany. The programme offers a wide range of support to families residing in Kenya and who have a family member in Germany with recognized refugee or subsidiary protection status.

### **RECOVERY AND RESILIENCE**

The Recovery and Resilience programming supports individuals and communities in Kenya affected by or vulnerable to the interconnected impacts of climate change, environmental degradation, natural hazards, conflict, and instability. IOM works to foster comprehensive and sustainable solutions to displacement, and strengthen resilience to existing and future risks.

Focused predominantly on climate change- and displacement-impacted communities in Arid and Semi-Arid Lands (ASALs) of Kenya, as well as on informal settlements in complex urban environments, IOM applies a humanitarian, development, and peace nexus (HDPN) approach to addressing needs, risks, and vulnerabilities over the short-, medium-, and long-term.

IOM's programming is centred around three broad pillars:

#### **MIGRATION HEALTH**

Migration Health programming supports and enables migrants, crisis-affected people, and people on the move to access and benefit from healthcare services, which improves their standard of physical, mental, and social wellbeing, so they can substantially contribute to social and economic development.

- Migration Health Assessments and Travel Assistance: Pre-migration health activities (PMHA) consist of preventive, curative, and promotional health services provided to migrants and refugees, aiming to detect health conditions of public health importance, ensure safety during travel, and provide continuity of care in the different stages of migration. PMHA is an array of procedures that are undertaken in the context of regular migration at the request of receiving country governments. IOM Kenya operates PMHA activity in Nairobi, Kakuma, and Dadaab and the services based in the Dadaab and Kakuma camps are primarily for resettling refugees. Predeparture medical services for resettlement purposes are for refugees living in Kakuma and Dadaab Refugee Camps.
- Health Promotion and Assistance for Migrants: Advocacy and provision of technical assistance on migrant-inclusive health policies, enhancing the capacity of governments and partners to provide migrant-friendly services and direct service delivery such as free healthcare services for migrants and host community members through the Eastleigh Community Wellness Center in Nairobi. The services include outpatient care, antenatal and postnatal care, SRHR, HIV/AIDS, and mental health and psychosocial support.
- Migration Health Assistance for Crisis-affected Communities: Enhancing capacity of government and partners on preparedness, detection, and response to public health events of international concern such as polio, cholera, COVID-19, and Ebola. In addition, border health capacity and surveillance, knowledge sharing, community sensitization, and screening are also supported.

#### **RESSETLEMENT AND MOVEMENT MANAGEMENT**



Providing essential support to States resettling refugees and other humanitarian entrants is a fundamental purpose of the Organization and its largest ongoing activity. IOM helps its Member States carry out a variety of resettlement and other humanitarian admission schemes, many of which are well-established programmes, while others are ad hoc responses to specific forced migration crises. IOM works closely with governments, the United Nations High Commissioner for Refugees (UNHCR), non-governmental organizations, and other partners, to enable resettlement.

In Kenya, IOM's Resettlement and Movement Management (RMM) programme facilitates safe refugee movements through the provision of logistical assistance to refugees and migrants that are travelling under IOM auspices. IOM's RMM and Migration Health teams collaborate to support refugees throughout the resettlement process. This can be inclusive of selection interviews, migration health assessments, cultural orientation, transit center assistance, document verification, and departure formalities/ airport assistance.

RMM teams work very closely with the Department of Refugee Services and the Directorate of Immigration Services to ensure that refugees and migrants moving throughout the country are supported and safe.

### DATA, RESEARCH, AND POLICY



The Data, Research, and Policy programming harnesses the power of data for operations, making meaning of global migration patterns, and informing foresight. IOM provides data for: action, foresight, and insight – supporting the Government of Kenya and partners in designing and implementing policies that serve migrants and displaced communities and support in building their resilience, improving preparedness, and providing solutions that contributes to the humanitarian, development, and peacebuilding nexus (HDPN).

Data is gathered and analysed to disseminate critical multi-layered information on the mobility, vulnerabilities, and needs of displaced and mobile populations that enables decision makers and responders in Kenya to provide these populations with better context specific assistance. In addition, it allows IOM with a coherent and systematic approach to analysis that integrates all relevant data and research for a comprehensive assessment on multi-dimensional drivers of migration and displacement, enabling more integrated and customized programming that is data-driven, context-specific, and scalable.

IOM's multisectoral assessments and analyses help stakeholders remain responsive to the evolving needs of crisis- and climateaffected communities over time and ensure that vulnerable communities, which may otherwise be overlooked, are not left behind.
